With it also comes the potential risk of sliding back on our efforts on physical distancing and staying home which have proved so effective in flattening the curve of COVID-19. We also know that many communities remain concerned about outside visitors at this time. As mentioned on the last update Indigenous Services Canada has been coordinating with other federal departments to get the message out to recreational boaters and others that now is not the time to travel through the West Coast.



Federal Wage Subsidy Being Extended To End Of August

Prime Minister Justin Trudeau announced today that the 75 per cent federal wage subsidy program is being expanded by three months (to end August) to assist employers as they look to reopen their businesses. With so many business closed or making little income, the **Canada Emergency Wage Subsidy** has evolved to a benefit looking to support businesses wanting to reopen, and bringing back workers, or hiring additional staff to accommodate the changed reality of COVID-19 and the public health prevention measures now required.

Canada Emergency Student Benefit application period launched today

The Canada Emergency Student Benefit (CESB) will be delivered by the Canada Revenue Agency (CRA), and will provide temporary income support to eligible

post-secondary students and new graduates who are unable to work or find work this summer due to COVID-19, or are working and are not making over \$1000.

Students are asked to register with **JobBank.gc.ca** to find available opportunities to earn an income and meaningful work experience.

Additional support fund now available to businesses and communities

The new Regional Relief and Recovery Fund (RRRF) devotes nearly \$962 million—including \$304.2 million for Western Canada—to help more businesses and organizations in sectors such as manufacturing, technology, tourism and others that are key to the regions and to local economies.

Businesses interested in receiving support through this initiative are now invited to apply for the RRRF through their local regional development agencies. In BC please contact, **Western Economic Diversification Canada**.

Canada Emergency Commercial Rental Assistance Program portal opens

Canada Mortgage and Housing Corporation opened their portal yesterday for the Canada Emergency Commercial Rental Assistance program (CECRA) for small businesses. It provides relief for small businesses experiencing financial hardship due to COVID-19 and offers forgivable loans to eligible commercial property owners to:

- reduce the rent owed by their impacted small business tenants
- meet operating expenses on commercial properties

Property owners must offer a minimum of a 75 per cent rent reduction for the months of April, May and June 2020 and now includes commercial leasing on reserve.

New support for Canada's fish harvesters

On Thursday, the Prime Minister announced **new support for Canada's fish harvesters**.

In consideration of fish harvesters who are economically impacted by the pandemic but cannot access existing federal measures, the Government of Canada is

committing up to \$469.4 million in new measures including the Fish Harvester Benefit, a program worth up to help provide income support for this year's fishing seasons to eligible self-employed fish harvesters who cannot access the **Canada Emergency Wage Subsidy**.

The investment builds on the \$62.5 million for the new Canadian Seafood Stabilization Fund announced last month to help Canada's fish and seafood processing sector.

K-12 students to have optional in-class instruction on June 1

The Province of BC has announced plans to support students attending provincial schools to return the classroom starting June 1 on a part-time basis. For kindergarten to Grade 5, this means most students will go to school half time (such as alternating days), while grades 6 to 12 will go to school about one day a week. Children of essential service workers and students needing additional supports will have the option to attend school full time. Families that decide not to send their children to class may continue learning from home. If parents have not heard from their schools by May 22, 2020, they are asked to contact their principal.

The Ministry of Education is working with all 60 school districts, independent school authorities, First Nations schools, teachers, school leaders, support staff, public health officials and all its education partners to coordinate the next steps for accommodating more students in class.

New dormant and orphan well restoration programs

In case you missed it, on Wednesday, BC announced what it is doing to accelerate the restoration of more than 2,000 orphan and inactive wells. Subject to reaching final agreement with Canada, Premier John Horgan said the programs will support upwards of 1,200 jobs, helping BC workers, the environment and our economy during these challenging times. Chief Sharleen Gale, of the Fort Nelson First Nation says this is "a winwin for the oil and gas sector and the environment. It will bring much needed local employment for former oil and gas workers and clean up dormant, legacy and orphan wells." The plan was also commended by the West Moberly, Doig River, and Saulteau First Nations.

COVID-19 Community Response Fund for Vulnerable Populations

The Federation of Canadian Municipalities (FCM) and the Canadian Medical Association Foundation are funding cities and communities to support vulnerable populations struggling with the impacts of the COVID-19 pandemic. The funds could help communities secure

Could I please get an update on the Estates unit's office closure?

On March 14, 2020, Indigenous Services Canada activated its business continuity plan. Since then, the services we provide to First Nations, including in the Estates unit. have been focused on essential services.

Payments on behalf of dependent adults and trust payments to those that are eligible are an essential service, and the BC Regional Office is continuing to make payments on behalf of dependent adult clients. New Estates work is being triaged, and when possible, urgent files are receiving action.
