UPDATE

The Prime Minister repeated today that the decision of when and how to re-open their communities remains with First Nations. "Indigenous communities are at a greater vulnerability to COVID-19 than others. That's why we put in place measures early on to help these communities protect themselves and be supported in this pandemic time. We know that as economies start to reopen, as activity picks up across the country, we're going to have to make, and local jurisdictions will have to make, decisions about how and where to reopen and we need to make sure that every step of the way people are working with all local stakeholders, including and specifically Indigenous communities and leadership, to ensure that we're not bringing in greater risks." he said.

As you consider what measures are needed for a safe re-opening of your administration offices and First

Nations businesses, please note that the Province of British Columbia has published a **guide to returning to safe operation – Phase 2**. BC advises employers develop a **COVID-19 Safety Plan** that outlines the policies, guidelines, and procedures they have put in place to reduce the risk of COVID-19 transmission. It is recommended employers involve frontline workers, joint health and safety committees, and supervisors in identifying protocols for their workplace.

Opening of program to protect jobs and help businesses

The Prime Minister also announced today that the application documents and updated criteria for **Canada Emergency Commercial Rent Assistance (CECRA)**

for small businesses are now available, and that the program will be opened for applications beginning on May 25. CECRA will provide forgivable loans to eligible commercial property owners, who in turn will give a rent reduction of at least 75 per cent for April and May (retroactive), and June, to their small business tenants.

Applications will be accepted through the **Canada Mortgage and Housing Corporation website** beginning on May 25, and application documents can be accessed now.

Government announces support program for large employers is open for applications

Additionally, Finance Minister Bill Morneau and Minister of Innovation, Science and Industry Navdeep Bains, today announced the opening of the application process for the government's **Large Employer Emergency Financing Facility (LEEFF)**. To qualify for LEEFF support, eligible businesses must be seeking financing of \$60 million or more, have significant operations or workforce in Canada, and not be involved in active insolvency proceedings. The LEEFF program will be designed to protect the interests of taxpayers and will require the cooperation of applicants' private sector lenders, to ensure government financing is focused on sustaining operations.

New supportive homes

In response to COVID-19, the BC government also says more than 2,400 spaces in hotels, motels and community centres throughout the province have been secured for vulnerable people to reside.

On Tuesday, **BC Housing, announced that it has purchased the former Raffles Inn motel in Prince Rupert** and will convert it into a permanent supportive housing building with up to 48 units, each with private washrooms, showers and mini kitchens. Construction will begin in fall 2020. The shelter portion of the building is expected to open in early 2021, with the supportive homes ready by fall 2021. Additionally, in Prince Rupert BC Housing has identified another site with 35 spaces as temporary accommodation for vulnerable people as part of its COVID-19 response.
