

COVID-19 MESSAGE FROM ISC BC REGION

UPDATE #72 / January 11, 2021

Good afternoon,

On Thursday, January 7, 2021, Provincial Health Officer Dr. Bonnie Henry issued an extension of the province-wide restrictions suspending all events and social gatherings through to midnight, February 5, 2021.

In addition to these orders, Dr. Henry recommends everyone limit their travel between communities and outside of the province unless it is absolutely essential for work or medical care.

As new COVID-19 cases continue to emerge in communities across BC, Dr. Henry urged people to “recommit to our efforts to slow down transmission.” She adds “Show your friends and neighbours they can count on you to make the right choices, every day, and together we will see brighter days once again.”

While the danger clearly remains, we are so pleased to see that vaccination has begun in rural and remote First Nations across the province. We celebrate with you this life-saving development. Thanks to the Gitga’at First Nation and First Nations Health Authority for allowing us to share the video in the banner below, and to the Tahltan Nation for sharing these inspiring photos of the roll out with us.

The facts about COVID-19 Vaccines

What is the COVID-19 vaccine?
Vaccines are products that produce immunity to a specific disease like COVID-19. When you are immune to COVID-19 that means you can be exposed to it without becoming sick or if you do become infected, it prevents more severe illness.

WHY IS IT IMPORTANT TO GET A COVID-19 VACCINATION?

COVID-19 vaccines provide excellent protection against the virus that causes COVID-19, preventing up to 95% of infections.	The vaccine protects you and the people around you, too. PROTECTING FIRST NATIONS PEOPLE IS A PRIORITY

December COVID-19 vaccines began rolling out to First Nations in BC at the end of December, 2020, and will be made more widely available over the next few months. The FNHA's Medical Officers strongly recommend that First Nations people opt to get the vaccine to protect you, your loved ones, Elders, and others in your community.

Even with the COVID-19 vaccines, we need to continue practising all recommended public health measures.

UPDATES

Indigenous Community Support Fund

As shared in **Update 71**, the **Fall Economic Statement 2020** commits the Government of Canada to provide a further \$380 million in 2020-21 for the **Indigenous Community Support Fund (ICSF)** to help ensure that the needs of Indigenous communities will continue to be met during the second wave.

Additionally, at the end of December, Minister Marc Miller announced that **\$30 million under the Emergency Food Security Fund** of Agriculture and Agri-Food Canada is also being used to bolster the ICSF bringing total investments under the ICSF to over \$1 billion since the beginning of the pandemic.

We were pleased to support many proposals before the end of 2020, but as previously noted, the demand far outstripped the available resources. We anticipate being able to support many more community applications on already submitted proposals with eligible costs in the near future and will share more details as soon as they become available.

Remarks from the Deputy Chief Public Health Officer on COVID-19

Canada's Deputy Chief Public Health Officer **provided remarks concerning the continuous fight against COVID-19 in Canada**. The address, on December 30, 2020, states that by September 2021, the Government of Canada is on track to offer vaccinations to everyone in Canada for whom vaccines are approved and recommended. Canada will also continue to monitor the cases of the COVID-19 variant identified in the United Kingdom that have been reported in Ontario, British Columbia, Alberta and Quebec.

BC commits \$105 Million to Support Tourism Sector

The Province of British Columbia is creating a dedicated relief funding stream to quickly support people and businesses in BC's tourism sector which have been hard hit by the travel restrictions in response to COVID-19.

In response to recommendations brought forward by its **Tourism Task Force**, the Province has **announced** \$100 million in dedicated relief funding for the tourism sector. In addition, the Province is also allocating \$5 million to Indigenous Tourism BC to administer relief grant funding targeted for Indigenous businesses.

BC will work in partnership with Indigenous Tourism BC on an Indigenous-led funding program specifically designed for Indigenous tourism operators. The dedicated relief funding for the tourism sector is intended to help people get through these next few months so they can welcome visitors back once it's safe to do so.

POVERTY REDUCTION GRANTS SUPPORT LOCAL GOVERNMENTS

Just a reminder that your neighbouring local governments will have the opportunity to apply for the second round of the **Province's Poverty Reduction Planning & Action Program grants** to help develop local strategies and solutions to address poverty.

Projects must involve key community partners, such as local First Nations or Indigenous organizations.

Applications for the second intake will be accepted until midnight (Pacific time), March 5, 2021.

Enhanced Incentives for Energy-Efficient Upgrades and Construction

Noting that many people are continuing to work from home due to the pandemic, the Province of BC is doubling CleanBC Better Homes retrofit rebates for select home-heating and energy-efficiency upgrades. The incentive is intended to make the switch to cleaner, more efficient technologies easier and support jobs across the province as part of the COVID-19 recovery. British Columbians wanting to switch from fossil fuel-based heating to cleaner, more energy-efficient heat pumps also have access to low-interest financing as part of CleanBC.

Applicants must pre-register for a promo code by March 31, 2021, and complete their upgrades by June 30, 2021, to participate.

In addition to these limited-time offers, two new programs have launched to further assist British Columbians in constructing and renovating more energy-efficient buildings. The **Better Homes New Construction Program** offers builders thousands of dollars for new residential construction in accordance with the BC Energy Step Code or for homes built with high-efficiency heat pumps. The **Commercial Express Program** provides financial incentives to builders who are retrofitting existing buildings, with a streamlined application process. Both programs are administered by BC Hydro.

- Because there will be limited quantities at first, once a vaccine is approved for use, key populations will need to be prioritized.

- Vaccination is a choice you should make to protect yourself, your family and community.
